1. Introduction

- 1.1 The Bognor Regis Campus has in place a CCTV surveillance system “the CCTV system” which covers the whole campus. The campus comprises of the following establishments: The Regis School (TRS); Southway Primary School (Southway); Stepping Stones Nursery (Nursery); Arena Sports Centre (Arena); & the Phoenix Centre (Phoenix). This policy details the purpose, use and management of the CCTV system by all users and details the procedures to be followed in order to ensure that the facilities complies with relevant legislation and the current Information Commissioner’s Office Code of Practice.
- 1.2 The establishments will conform to the requirements of the Data Protection Act 2018, the General Data Protection Regulation (GDPR) and any subsequent data protection legislation, and to the Freedom of Information Act 2000, the Protection of Freedoms Act 2012 and the Human Rights Act 1998. Although not a relevant authority, the Facilities will also have due regard to the Surveillance Camera Code of Practice, issued under the Protection of Freedoms Act 2012 and in particular the 12 guiding principles contained therein.
- 1.3 This policy is based upon guidance issued by the Information Commissioner’s Office, ‘In the picture: A data protection code of practice for surveillance cameras and personal information’ (“the Information Commissioner’s Guidance”).
- 1.4 This policy and the procedures therein detailed, applies to all of the CCTV systems including webcams, covert installations and any other system capturing images of identifiable individuals for the purpose of viewing and or recording the activities of such individuals. CCTV images are monitored and recorded in strict accordance with this policy.

2. CCTV System overview

- 2.1 Whilst the CCTV system is a shared resource by all the campus establishments, the CCTV system is owned by The Regis School, Westloats Lane, Bognor Regis, West Sussex, PO21 5LH, and managed by TRS and its appointed agents. The data controller for CCTV images held by TRS is United Learning Trust (ULT). ULT is registered with the Information Commissioner's Office (ICO). The registration number is Z7415170.

The Group's Data Protection Officer, Alison Hussain, is responsible for ensuring that ULT complies with the Data Protection Law. She can be contacted on company.secretary@unitedlearning.org.uk or 01832 864538

The CCTV system operates to meet the requirements of the Data Protection Act 2018 and the Information Commissioner's Guidance.

- 2.2 TRS designated Data Protection Lead is responsible for the overall management and operation of the CCTV system, including activities relating to installations, recording, reviewing, monitoring and ensuring compliance with this policy.
- 2.3 The CCTV system operates across the campus. Details of the number of cameras can be given on request.
- 2.4 Clearly visible signs are placed at all pedestrian and vehicular entrances to inform staff, pupils, parents, visitors and members of the public that CCTV is in operation. The signage indicates that the system is managed by the School and a 24-hour contact number for the Security Control Centre is provided at the front of the school building.
- 2.5 The Data Protection Lead is responsible for ensuring that adequate signage is erected in compliance with the ICO CCTV Code of Practice.
- 2.6 Cameras are sited to ensure that they cover campus premises as far as is possible. Cameras are installed throughout the campus's sites including roadways, car parks, buildings (internal and external), within buildings and externally in vulnerable public facing areas.
- 2.7 Cameras are not sited to focus on private residential areas. Where cameras overlook residential areas, privacy screening or software masking will be utilised.
- 2.8 The CCTV system is operational and capable of being monitored for 24 hours a day, every day of the year.
- 2.9 Any CCTV installation shall be subject to a Data Protection Impact Assessment. It will also comply with the policy and procedures within this document. The Data Protection Impact Assessment shall be appended to this policy and shared with Central Office Data Protection Officer

3. Purposes of the CCTV system

- 3.1 The principal purposes of the CCTV system are as follows:
 - for the prevention, reduction, detection and investigation of crime and other incidents;
 - to ensure the safety of staff, children, visitors and members of the public; and
 - to assist in the investigation of suspected breaches of regulations by staff or students.
- 3.2 The CCTV system will be used to observe the campus's buildings and areas under surveillance to identify incidents requiring a response. Any response should be proportionate to the incident being witnessed.
- 3.3 The Facilities see to operate its CCTV system in a manner that is consistent with respect for the individual's privacy as outlined in the Privacy Impact Assessment.

4. Monitoring and Recording

- 4.1 The CCTV system has the ability to limit access to certain sections of the system depending on requirements of each area of the campus. The CCTV system has over 280 fixed cameras located both internally & externally across the campus. The system has five distinct areas, which are TRS, Southway, Nursery, Arena & Phoenix.

The table below shows which offices that can view which camera areas:

- TRS Facility Manager (Whole site)
- Network Manager (Whole site)
- Director of Business (Whole site)
- Southway & Stepping Stones Business Manager (Southway & Nursery)
- Vice Principal (TRS only)
- Assistant Principals (TRS only)
- Southway Principal (Southway & Nursery)
- Southway Premises Manager (Southway)

All these offices are secure and staffed during the time the CCTV can be monitored.

- 4.2 Images are recorded centrally on servers located in either Southway's or TRS's secure network and are viewable in the offices above. All staff named below have had CCTV training & have read & understood this policy. Additional staff may be authorised by either TRS or Southway Principal to monitor cameras on a view only basis to support trained staff i.e. in identifying specific children. Trained staff are as follows (with access to):

- 4.3 A log shall be kept of requests to access recorded images by staff and whether any recorded images have been copied to support specific investigations. This log is completed by the trained member of staff that saves the images. Information logged should include: Name of staff, time and date of viewing, time and date of images reviewed, brief reason for viewing content (e.g. "incident in corridor") but should not contain names, whether any images have been copied and where they have been copied to. It also includes if the recording had been deleted according to the School's retention policy.

- 4.4 The cameras installed shall provide images that are of suitable quality for the specified purposes for which they are installed, and all cameras are checked regularly to ensure that the images remain fit for purpose and that the date and time stamp recorded on the images is accurate.
- 4.5 All images recorded by the CCTV System remain the property and copyright of United Learning. The recorded images are stored onsite on a secure Network Video Recorders (NVR). Downloaded footage used in investigations is securely stored onsite on the secure server. This is kept in accordance with the process outlined in the retention of images section.
- 4.6 The use of cameras placed in the front of the classroom to monitor student behaviour will be carried out in accordance with Part 3 of the Employment Practices Code. The monitoring of classrooms should be clearly identified in the Privacy Impact Assessment. This should cover:
- identifying clearly the purpose(s) behind the monitoring arrangement and the benefits it is likely to deliver
 - identifying any likely adverse impact of the monitoring arrangement
 - considering alternatives to monitoring or different ways in which it might be carried out
 - taking into account the obligations that arise from monitoring
 - judging whether monitoring is justified
- 4.7 The CCTV system should not be used to carry out lesson observations.
- 4.8 The use of cameras in areas where one would normally expect a degree of privacy should be clearly identified on the Privacy Impact Assessment. This would include cameras placed in, or looking into, toilet or changing areas. Cameras should only be used in toilet or changing areas where there are full height cubicles, never in areas where it is possible to see people using the toileting facilities (excluding hand washing) or changing.
- 4.9 The use of covert cameras will be restricted to rare occasions, when a series of criminal acts have taken place within a particular area that is not otherwise fitted with CCTV. A request for the use of covert cameras will clearly state the purpose and reasons for use and the authority of both one of the Principals and Director of People will be sought before the installation of any covert cameras. The Principals should be satisfied and be able to demonstrate that all other physical methods of prevention have been exhausted prior to the use of covert recording.
- 4.10 Covert recording will only take place if informing the individual(s) concerned would seriously prejudice the reason for making the recording and where there are reasonable grounds to suspect that illegal or unauthorised activity is taking place. All such monitoring will be fully documented and will only take place for a limited and reasonable period.

5. Compliance with Data Protection Legislation

- 5.1 The School will also comply with the UK General Data Protection Regulation. Due regard will be given to the data protection principles contained within Article 5 of the UK GDPR which provide that personal data shall be:
- a. processed lawfully, fairly and in a transparent manner;
 - b. collected for specified, explicit and legitimate purposes and not further processed in a manner that is incompatible with those purposes;
 - c. adequate, relevant and limited to what is necessary in relation to the purposes for which they are processed;
 - d. accurate and, where necessary, kept up to date;
 - e. kept in a form which permits identification of the data subjects for no longer than is necessary for the purposes for which the personal data are processed; and
 - f. processed in a manner that ensures appropriate security of the personal data, including protection against unauthorized or unlawful processing and against accidental loss, destruction or damage, using appropriate technical or organisational measures.
- 5.2 All storage used for images, recorded or downloaded for investigations, must be in compliance with UK GDPR rules; on secure storage on premise or on cloud storage within the EEA
- 5.3 The existence of the campus's CCTV system must be recorded in the Record of Data Processing Activities using United Learning's Education Information Portal (EIP).

6. Applications for disclosure of images

Applications by individual data subjects

- 6.1 Requests by individual data subjects for images relating to themselves “Subject Access Request” should be submitted in writing.
- 6.2 In order to locate the images on the School’s system, sufficient detail must be provided by the data subject in order to allow the relevant images to be located and the data subject to be identified.
- 6.3 Where the School is unable to comply with a Subject Access Request without disclosing the personal data of another individual who is identified or identifiable from that information, it is not obliged to comply with the request unless satisfied that the individual has provided their express consent to the disclosure, or if it is reasonable, having regard to the circumstances, to comply without the consent of the individual. Any decision to withhold the requested images must be referred to the Group’s Data Protection Officer or his team as there are specific rules that must be adhered to when applying the exemptions contained in the Data Protection Act 2018.

Access to and disclosure of images to third parties

- 6.4 A request for images made by a third party should be made in writing.
- 6.5 In limited circumstances it may be appropriate to disclose images to a third party, such as when a disclosure is required by law, in relation to the prevention or detection of crime or in other circumstances where an exemption applies under relevant legislation.
- 6.6 All unexpected requests for CCTV images by a third parties, including requests made by the police, should be referred to the School’s Data Protection Lead in the first instance and if not available to the Group’s Data Protection Officer or their team, who will advise on the application of any appropriate exemptions. Any third-party request should be added to the EIP in the GDPR area under *third party requests*.
- 6.7 Where a suspicion of misconduct arises and at the formal request of the Investigating Officer or HR Manager/ Business Partner, the Principal may provide access to CCTV images for use in staff disciplinary cases.
- 6.8 The Principal may provide access to CCTV images to Investigating Officers when sought as evidence in relation to staff discipline cases.
- 6.9 A record of any disclosure made under this policy will be held on the CCTV management system, itemising the date, time, camera, requestor, authoriser and reason for the disclosure.

7. Retention of images

- 7.1 Unless required for evidential purposes, the investigation of an offence or as required by law, CCTV images will be retained for no longer than 14 days from the date of recording. Images will be automatically overwritten after this point.
- 7.2 The deletion of data after the defined retention period on the 'Z' drive should be checked on a half termly basis and deleted. This will be carried out by the Network Manager & in his absence either the Director of Business or the Lettings & Facilities Manager. This should be logged on a half termly basis.
- 7.3 Where an image is required to be held in excess of the retention period referred to in 7.2, the Principal or their nominated deputy will be responsible for authorising such a request. A record of these stored images will be kept within the CCTV viewing log.
- 7.4 Images held in excess of their retention period will be reviewed on a three-monthly basis and any not required for evidential purposes will be deleted. The CCTV monitoring log will provide evidence of the images which have been held and where they are kept. When deleted this should be recorded in the CCTV monitoring log.
- 7.5 Access to retained CCTV images is restricted to the Principal and other persons as required and as authorised by either of the Principals. These individuals are: Mark Betts, Will Knight, Cameron Bashford, Katherine Bartlett, Caroline Saunders, Nathaniel Hall, Ray Crimmen, Dave Sibert, Simon Coppard, Darren Regan, Alan Coffin, Rachel Domagala and Jenny Brakefield.

8. Complaints procedure

- 8.1 Complaints concerning TRS, Arena or Phoenix use of its CCTV system or the disclosure of CCTV images should be made in writing to the Principal at The Regis School, Westloats Lane, Bognor Regis, West Sussex, PO21 5LH. If the complaint is concerning Southway or the Nursery use of its CCTV system or the disclosure of CCTV images should be made in writing to the Principal at Southway Primary School, Southway, Bognor Regis, West Sussex, PO21 5EZ. Any complaint will be handled in accordance with the relevant School's complaints policy.
- 8.2 All appeals against the decision of the Principal should be made in writing to the relevant Chair of Governors.

9. Monitoring Compliance

- 9.1 All staff involved in the operation of the School's CCTV System will be made aware of this policy and will only be authorised to use the CCTV System in a way that is consistent with the purposes and procedures contained therein.
- 9.2 All staff with responsibility for accessing, recording, disclosing or otherwise processing CCTV images will be required to have undertaken United Learning Data Protection training.

10. Policy review

- 10.1 The School's usage of CCTV and the content of this policy shall be reviewed annually by the relevant Principal with reference to the relevant legislation or guidance in effect at the time. Further reviews will take place as required.
